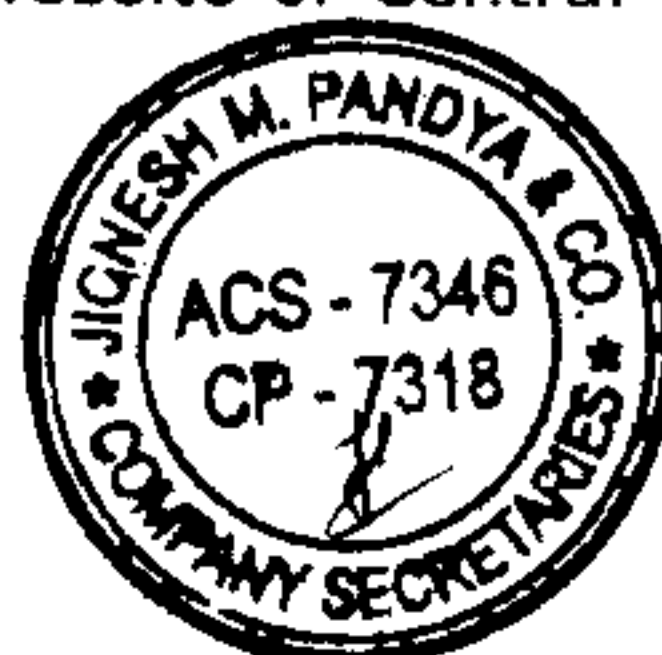
REPORT OF THE SCRUTINIZER

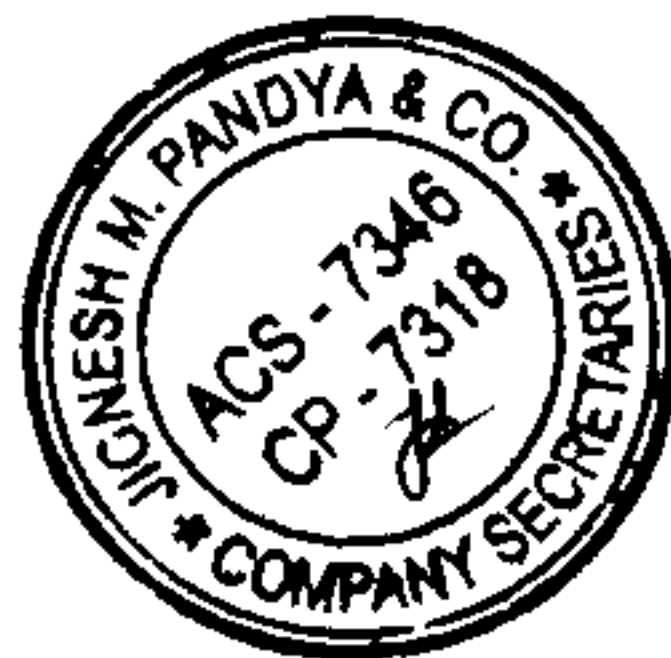

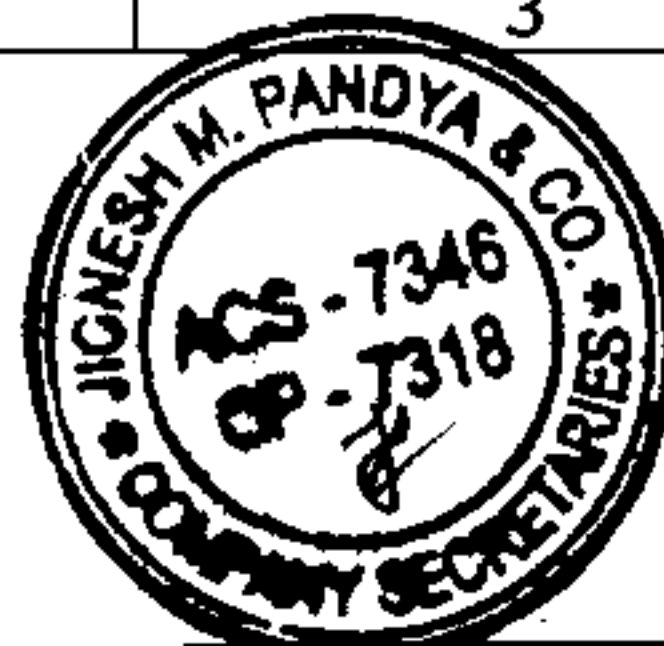
